- 36 months of project risk management experience within the last 5 years, and
- 40 hours of project risk management education.

OR

2. Four-years degree (bachelor's degree or the global equivalent),

- 24 months of project risk management experience within the last 5 years, and
- 30 hours of project risk management education

3. Meet the requirements of IPA's Policy for Risk Management Professional (PMI-RMP®) Exam Preparation Workshop.

◇ Features and Lessons:
